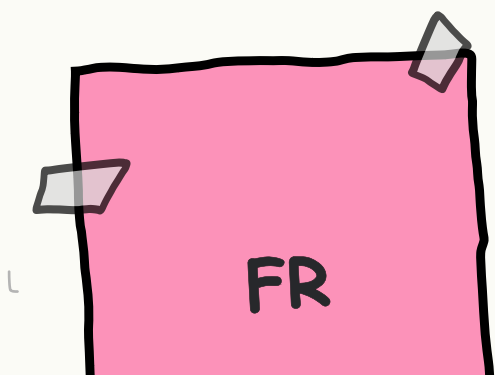
- Device And Browser Type
